This requisition obligates the board of directors to call and hold a Meeting of Owners under s.46 (4) of the *Condominium Act, 1998*.

Please note, to sign this requisition, a person must:</p> <ul style="list-style-type: none"> <li>• Be the owner of a unit;</li> <li>• Be entitled to vote on behalf of their unit; and,</li> <li>• Not be in arrears for any common expenses for 30 days or more.</li> </ul>
<p><b>Additional Information</b></p>	<ul style="list-style-type: none"> <li>• Tenants or other non-owner occupants of a unit cannot sign a requisition.</li> <li>• Owners of multiple units only need to sign the requisition form once but must identify all the units they own in the Unit ID or Unit No. column of the requisition's signature page.</li> <li>• The joint-owners of a single unit may sign the requisition if a majority of the joint-owners agree to signing.</li> <li>• Electronic signatures may be used to sign a requisition if the signatures meet the requirements of section 11 of the <i>Electronic Commerce Act, 2000</i>.</li> </ul>
